Using the "At a Glance" display features of the CertiScan software, Med-ic equipped packages can be scanned and patient compliance data is instantly available on screen with an intuitive and easy to follow layout. A scattergram diagram can pinpoint problematic behaviour (e.g. late dosing on weekends).

Missed or incorrect doses are highlighted in red to indicate non-compliance with prescribed dosing times and amounts. The calendar feature contains a "drill down" capability allowing the user to pinpoint the time of dosing to the minute.

Irregular dosing patterns are clearly visible. Patients can be counseled with remedial education to improve their dosing adherence.
